All bidding activities will proceed based on the specified schedule and venue. The technical specifications and other relevant details of the items for procurement are outlined in the bidding documents, which will be provided only to bidders who have completed the purchase.

The Pre-bid Conference will be conducted in person and is open only to those who have purchased the bidding documents. This conference provides an opportunity for bidders to raise questions and seek clarifications regarding the bidding process. The Opening of Bids will also be conducted face-to-face.

The procurement process will follow a COMPETITIVE BIDDING procedure, using a non-discretionary "pass/fail" criterion, in accordance with NEA Memorandum No. 2017-019, also known as the *Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives*.

NORECO II reserves the right to reject any or all bids, declare a failure of bidding, or cancel the bidding process at any time before the contract is awarded, without incurring any liability to the affected bidder or bidders.
